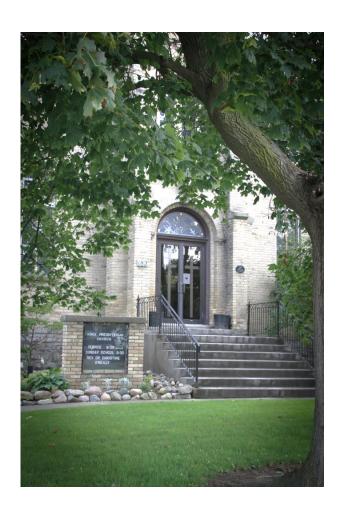

Over the last year we have wept and wondered, and likely worried...and we are learning to trust God more deeply.

God has not abandoned us. We still worship Him, apart, yet bound together by the Holy Spirt. We have had more small group gatherings than ever; at the moment, we have 5 groups meeting each week for study and yes, to be together. We have reached people beyond our usual number- people who live in different places join us for worship each Sunday, and in our small group meetings. We have tried to stay connected in many different ways. We have online devotions Monday to Friday – Kids QT each morning at 7 a.m., and Holding Bread at 9.30 p.m. Youth have met online and in person. Knitters met in the parking lot and the front lawn. We did VBC online, and had more kids than we thought we would. People have prayed and cared and kept in touch. I am thankful.

So – 2021. What will happen? Who knows. When will be worship together again in person? I don't want to predict anything. Anything except God's faithfulness, that is! As we GROW DEEP. LIVE STRONG. this year, we know that the Lord is and will be with us...and that He is and will be at work, doing something more than we can ask or imagine.

Thank you for your ongoing faithful presence, support and prayers. I am so thankful for you!

This has indeed been an unusual year for the Board of Managers. With the onset of the COVID-19 pandemic a lot of things came to a screeching halt. What did not come to a halt was the work of the Board in maintaining the church building and providing whatever assistance we could to Pastor Chris, Jesse, Jim, Catherine, Barb and the entire worship team in order to facilitate the online streaming of our worship services.

With all services being streamed and no in-person services it became important to find different ways for members and people watching online to be able to tithe and make donations in order to meet our financial obligations.

The PAR program has been expanded to use by almost 30 individuals and families. We were also able to find ways for people to donate through online banking etransfers and by credit card. This has worked out very well.

With the start of opening the church building back up to some groups as well as planning for a return to in-person worship Services, it became necessary to start working on policies for doing this as well as for ensuring that appropriate measures were in place and sanitizing and cleaning products were available to safely do this. A sub-committee was put in place to ensure that proper supplies were available in the building and to create the necessary policies.

Although we have not been able to resume in-person services yet, we will be prepared when the time comes.

The Board has spent the bulk of the year 2020 in maintaining the property and building while placing most major projects on hold in order to preserve or financial liquidity. We are continuing to put funds aside each year to allow us to have some much-needed brick work done on the building once things begin to return to normal.

Due to the increased importance of our audio and video capabilities during this pandemic, we have continued to budget for upgrade this equipment. Many thanks to Jesse for his continued work in these upgrades.

Future Considerations for 2021

As the year 2021 moves forward and we (hopefully) begin to open up programs and worship services to in-person, the Board of Managers will again focus on our list of medium and long-term projects.

We welcome suggestions or recommendations from any member of the congregation. We also request that, for anyone who is able, to sign-up for our PAR (Pre-authorized Remittance) program. It is a simple and painless process. You can contact Wendy Moffatt or any of the Board members for more details.

Board Status

Barry Cavanagh has moved away but continues to be involved in the Board meetings. Ken Chiurko will be stepping down from the Board. We would like to thank Ken for his years of service.
